## ACL Laboratories Offers Comprehensive Drug Screen - Pain Management Profile 1 (Test Order Code QPNMG1)

**Effective Wednesday, February 20, 2019,** ACL Laboratories will offer Pain Management Profile 1 (Test Order Code QPNMG1), a comprehensive drug screen. With this new offering, the following pain management tests will be deactivated:

- Drug Abuse Panel Drug Management (Test Order Code DMABUS)
- Pain Management Drug Panel (Test Order Code DRGPM2)
- Pain Management Drug Screen with Interpretation (Test Order Code DRUGPM).

Pain Management Profile 1 (Test Order Code QPNMG1), a comprehensive drug screen, is intended for use in pain management patients and those requiring routine drug monitoring. The panel utilizes immunoassay screening methods and definitive LC/MS methods to test for common prescribed and abused drugs. All positive immunoassay results auto-reflex to definitive LC/MS testing, and all positive results are quantitatively reported. Patient medication information must be provided to receive an interpretative report. Results will indicate whether findings are consistent or inconsistent with supplied medication information.

The specimen requirements are as follows:

Volume	30.0 mL Random Urine	
Collection	Must be collected in a sterile urine container. Do <i>not</i> transfer into an aliquot tube	
Transport	Refrigerated	

The following drugs/classes of drugs will be screened and ALL positive results will auto-reflex to definitive LC/MS confirmation:
